NET METERING INFORMATION

The City of La Junta supplies customers with electricity through the city usage meter, day and night (when there is no solar production). Customer production is measured by a separate production meter.

Net Metering:

- Electric Department supplies solar customer readings to ARPA
- ARPA bills the City of La Junta for solar-generated power
- Customer Generated Electricity ~ Any excess will go back to the (La Junta) Grid
- Excess production shows on the customer City of La Junta utility bill
- Customer receives avoided cost as a rebate multiplied by kWh returned to the system
- Once (1) per year, the customer will receive a credit on their bill

The Customer Must Complete The Following:

- Residential Limit ~ 10kW Commercial Limit ~ 25kW
- Building Department Solar Application & Checklist; all plans must include a Production Meter Can
- There are two meters
 - o Production Meter
 - Generation Meter
- Contract for Net Metering
- Mounting Bracket Inspection (before panels installed)
- Final Inspection from City Building Department
- Final Inspection from State Electrical Inspector

Example ~ Per Billing Period

If the customer returns 1,000 kWh to the grid, the city rebates the avoided cost of generation (approximately .05/kWh)

1,000 kWh <u>X 0.05</u> Avoided Cost \$ 50.00 Rebate

Net Metering:

Customer Generated Electricity ~ Any excess will go back to the (La Junta) Grid. Customer receives avoided cost as a rebate. La Junta pays ARPA for generated Kw. La Junta sells excess to customers.

Electric Department supplies Solar Customer readings to ARPA. ARPA bills La Junta for generated power. City of La Junta refunds customer at avoided cost.

By signing below, the applicant, contractor, and homeowner acknowledges that the Engineering Department and the State Electrical Inspector must complete required inspections before a Certificate of Occupancy can be issued. Also, by signing you acknowledge and understand City of La Junta's Net Metering. A Certificate of Occupancy must be issued before connection of the production meter occurs.

Customer Owned Generation (COG) Contract

Customer-sited Generation System

- 1. Purchase and sale. On the terms and subject to the conditions set forth in this contract, the customer agrees to assign all Renewable Energy Credits ("RECs") generated by the Customer Owned Generation (COG) at the address listed to La Junta Electric Department for a term of twenty (20) years from the installation date set forth in the Certificate of Completion.
- **2. Representations.** The signatories hereto individually and collectively make the following representations:
 - **a.** They are individually authorized and competent to sign this Contract and they have read the Contract and agree to be bound by its items.
 - **b.** Customer receives electric service from La Junta Electric Department at the address set forth above, and for the purpose of this Contract is the person in whose name electric service is listed at the service premise.
 - **c.** Customer is an end-use electric customer located within the electric service territory of La Junta Electric Department in Colorado, whose primary business is not the generation of electricity for retail or wholesale from the same facility.
 - **d.** The customer has installed a new COG system at the service premise, which has at least a two-year warranty, as of the date set forth, and conforms to the specifications, as described in La Junta Electric Department's interconnect agreement.
 - e. If the COG system is photovoltaic the orientation of the COG system is free from shade trees, buildings and other obstructions that might shade the orientation of the system measured from the center point of the solar array through a horizontal angle plus or minus 60 degrees and through a vertical angle between 15 degrees and 90 degrees above the horizontal plane.

3. Terms and Conditions.

- **a.** Customer shall be solely responsible for ensuring the COG system equipment installed for this program meets all applicable codes, standards, and regulatory requirements.
- **b.** The COG system shall be located on the Customer's electric service premises at all times during the terms of this contract.
- **c.** The COG system shall be a minimum capacity of 500 watts and a maximum capacity not to exceed 25 kilowatts, nameplate output capacity.
- d. The term of this Contract shall be one (1) year beginning ______; and shall be annually renewable for a period of twenty (20) years with mutual consent of all signatories; however, this Contract is assignable by Customer to any subsequent purchaser of customer's premises. La Junta Electric Department shall own all RECs produced by the COG system during the Term of this Contract.
- **e.** La Junta Electric Department shall receive all excess energy, if any, generated by the COG system at the service premise and not used by the Customer. The Customer will receive compensation for the energy generated by the COG system and not used by the Customer at the premise via "net metering" as set forth in La Junta Electric Department net metering Tariff as the same may be charged from time to time.
- f. This Contract shall apply to new COG equipment only. Used equipment does not qualify for the incentive.
- **g.** La Junta Electric Department does not imply any representation or warranty of the design, installation, or operation of the COG equipment and La Junta Electric Department expressly disclaims any and all warranties of the equipment as to workmanship, quality, or performance, including the fitness of the equipment for the purpose intended.
- **h.** La Junta Electric Department shall not be responsible or liable for any personal injury or property damage caused by the COG system or any individual component equipment of the system.
- i. Customer shall indemnify, defend, and hold La Junta Electric Department, its employees, agents, successors, assigns, subsidiaries and affiliates harmless against any and all claims, demands, liens, lawsuits, judgments, or actions of whatsoever nature that may be brought on account of the installation, maintenance, operation, repair or replacement of the COG system or any component equipment on the system.
- **j.** Customer shall comply with all of the rules stated in the La Junta Electric Department's applicable Electric Tariff and Interconnection Agreement as the same may be revised from time to time. In the event of any conflict between the terms of this contract and the Electric Tariff and/or Interconnection Agreement, the provisions of the Tariff or agreement shall control.
- **k.** The customer shall maintain the COG system and the individual components of the system in good working order at all times during the Term of this contract. If during the Term of this contract, the COG system or any of the individual components of the system should be damaged or destroyed, the Customer shall promptly repair or replace the equipment to its original specifications, and, if applicable, tilt and orientation, at the customer's sole expense.

- Learn Customer shall procure and maintain in effect at all times during the Term of this contract liability insurance as specified in La Junta Electric Department's Small Power Producer Standards and Requirements. La Junta Electric Department reserves the right to alter the amounts of liability insurance required as necessary to assure the safety and protection of its equipment, employees, and customers.
- **m.** This Contract and the terms contained in this contract shall be binding and enforceable against the parties for as long as the Contract remains in effect.
- **n.** If any disputes arise concerning this Contract, including but not limited to enforcement of any term or condition of this contract, the prevailing party in any action brought for the purpose of enforcing such provisions shall be entitled to recover its reasonable attorney fees, expenses and costs of such action from the non-prevailing party.
- **o.** Failure of either party to enforce any term or condition of this Contract shall not constitute a waiver of that term or condition or of any term or condition of this Contract.
- **p.** The parties agree that a cause of action for breach of any provision of this Contract shall not accrue until the non-breaching party actually discovers the breach.
- **q.** If any of the representations of the parties are false or incorrect, such false or incorrect representation shall constitute a material breach of this Contract.
- **r.** This Contract shall be governed by and interpreted in accordance with the laws of the State of Colorado.
- **s.** This Agreement may be executed in two or more counterparts, each of which is deemed original but all constitute one and the same instrument. The parties agree that a facsimile copy of a signature will be deemed original and binding.
- t. This Agreement shall be binding upon and inure to the benefit of the successors and assigns of the respective parties hereto. In order for an assignment to be effective, Customer is required to provide to assignee the following documents: Assignment Agreement, a copy of this contract, a copy of the Interconnection Agreement, and any remaining warranty information. Customer is released from any and all future liability under this contract upon its assignment.
- **u.** By executing this Contract, Customer grants to La Junta Electric Department permission to share the location of the COG system and other information concerning the RECs sold to La Junta Electric Department by Customer under this contract to other Colorado Public Utilities, Municipalities, Cooperatives, and other entities that may be involved with the transaction of RECs for the limited purpose of ensuring that the RECs associated with the COG system have not been sold to another entity.
